## 3. **Better Planning**



### Key Dates for Donors

| Date              | Topic                 | Note   |
|-------------------|-----------------------|--|
| November 14, 2025 | New Charities         | For grants to new organizations, TrustBridge strongly advises submitting your charity recommendations on or before November 14, 2025. This will provide your recommended charity plenty of time to submit their Charity Fund application to TrustBridge. |
| December 1, 2025  | Foundation Fund       | Contributions intended to fund a grant to a charity in the calendar year 2025 need to be in your TrustBridge Foundation Fund by December 1, 2025.  |
| December 9, 2025  | Recurring Bank Checks | Recurring bank checks should be received no later than December 9, 2025.   |
| December 15, 2025 | Online Payments       | All electronic donation dates (i.e. ACH, SEPA, etc.) should be completed by December 15, 2025.   |
| December 22, 2025 | Wires                 | Wire transfers to TrustBridge Global accounts should be done by December 22, 2025 at the latest.   |
| December 22, 2025 | Stocks                | Stock donations need to be made by December 22, 2025 at the latest.  |
| December 30, 2025 | Credit Cards          | Credit card donations should be processed on or before December 30, 2025.  |
| December 31, 2025 | Physical Checks       | U.S. donors giving by physical checks need to have their checks postmarked by December 31, 2025 at the latest.   |

### Key Dates for Charities

| Date               | Note   |
|--------------------|--|
| September 30, 2025 | New projects need to be entered by charities in GivingSpace by September 30, 2025.   |
| November 14, 2025  | Creation of new Charity Funds should be completed by November 14, 2025 to facilitate gift distributions within 2025.       |
| December 16, 2025  | Charity distribution requests entered through the TrustBridge Global Portal should be made on or before December 16, 2025. |
