

What We Do


TrustBridge believes global giving should be easy so that resources can flow to the areas of the world that need it the most.

Your Foundation Fund

A Foundation Fund is the premier donor-advised fund (DAF) from TrustBridge Global offering donors an international platform for charitable giving from a trusted Swiss host.

With a Foundation Fund, you can navigate the complex international banking system and laws and avoid the expensive transactions and endless red tape that would leave your generosity stranded at the border. You can see your grants flow safely, quickly, and affordably to wherever you want your giving journey to go.

Whether you are looking for grant-making flexibility, charitable asset protection, excellent service, or the simplicity of managing your philanthropy from one place, the Foundation Fund is your perfect global giving solution. Generosity on a global scale requires expertise and a great team. With administrative hassles out of the way, you can stay focused on the most important aspects of giving: making an impact, receiving joy, and improving lives all around the world.



Domestic Or International Grants

When you are ready to send money to a charity, it's easy to follow these steps:

1. Contact our team and tell us where you want your grant to go. We'll contact the charity, confirm their legal status, verify their bank accounts, manage all compliance and legal regulations, and ensure they are equipped to handle the donation.
2. When your charity is approved, you can give by transferring money from your bank, by using your Foundation Fund, or a Fund managed by a member of our extensive global network.
3. TrustBridge handles the rest; ensuring your charity safely receives the grant in their local bank account. Grant assessments are typically only 1%, subject to a CHF300 minimum.


Protect Your Charitable Assets In Switzerland

Who can open a Foundation Fund?

A Foundation Fund is a perfect giving solution for individuals, private foundations, families, companies, and even charitable organizations. A donor-advised fund can be a flexible part of many giving solutions.

How much does it cost?

TrustBridge shares the cost of operations proportionally among its donors. It collects an annual administrative assessment of only 30 basis points (0.3%) per year (charged monthly based on the average daily balance). Other costs vary based on investment selections and unique administrative services provided.

How do I give to my Foundation Fund?

You can contribute liquid currencies, appreciated assets like stock or real estate, or other valuable assets. Let our experts help you maximize your giving. Even if you are a dual-country taxpayer or have tax obligations in many countries, we can help you send more to charity and less to taxes.

What investment options can I recommend for my DAF balance?

Several time duration options exist and custom investment options can also be accommodated including exposure to multiple international exchanges.

Can I transfer an existing balance?

Yes, DAF or private foundation assets in many countries can easily be moved to your Foundation Fund.

The purpose of the Maclellan Foundation is to provide financial and leadership resources to foster biblical Christian values in the community and meet practical and spiritual needs. This is primarily accomplished through faith-based ministries. On a national basis, the foundation's vision is to see strong families worshipping in healthy churches, influencing culture, and seeking to serve God above all else.

Maclellan's Situation

- Some of Maclellan's projects are in closed countries that Maclellan couldn't reach.
- Some grants cost unreasonable amounts in fees.
- Some providers offered less personal touch and set a lower bar for customer service.
- When making some technically challenging grants, Maclellan wanted another set of eyes to provide legal assurance but didn't know where to turn.
- In one instance, the best way to serve a grantee in Europe was through a loan rather than a direct grant. Maclellan knew that was the right answer but did not know how to execute.


