What is a Foundation Fund?



TrustBridge Global Foundation is a Stiftung registered in Switzerland. This structure enables the shared foundation services that make the Foundation Fund possible. More information on our registration, audits, and financials is available upon request.

How much does it cost?

TrustBridge Global Foundation shares the cost of operations proportionately among its donors. It collects an annual administrative assessment of only 30 basis points (0.3%) per year (charged monthly based on the average daily balance). Other costs vary based on investment selections and unique administrative services provided.
