Giving early helps reduce the risk of missing important cutoffs and provides more time for your contribution to be processed within the appropriate tax year.

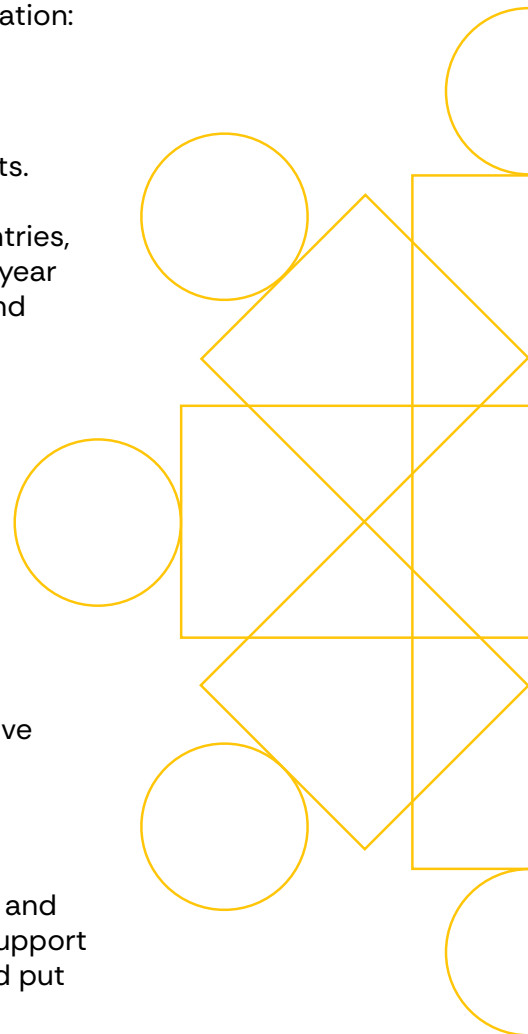
2. **Allow Time for Charity Vetting**

Key Dates for Donors

Date	Topic	Note
November 14, 2026	New Charities	For grants to new organizations, TrustBridge strongly advises submitting your charity recommendations on or before November 14, 2026. This will provide your recommended charity plenty of time to submit their Charity Fund application to TrustBridge.
December 1, 2026	Foundation Fund	Contributions intended to fund a grant to a charity in the calendar year 2026 need to be in your TrustBridge Foundation Fund by December 1, 2026.
December 9, 2026	Recurring Bank Checks	Recurring bank checks should be received no later than December 9, 2026.
December 15, 2026	Online Payments	All electronic donation dates (i.e. ACH, SEPA, etc.) should be completed by December 15, 2026.
December 22, 2026	Wires	Wire transfers to TrustBridge Global accounts should be done by December 22, 2026 at the latest.

Date	Topic	Note
December 22, 2026	Stocks	Stock donations need to be made by December 22, 2026 at the latest.
December 30, 2026	Credit Cards	Credit card donations should be processed on or before December 30, 2026.
December 31, 2026	Physical Checks	U.S. donors giving by physical checks need to have their checks postmarked by December 31, 2026 at the latest.

Key Dates for Charities

Date	Note
September 30, 2026	New projects need to be entered by charities in GivingSpace by September 30, 2026.
November 14, 2026	Creation of new Charity Funds should be completed by November 14, 2026 to facilitate gift distributions within 2026.
December 16, 2026	Charity distribution requests entered through Fund Management in GivingSpace should be made on or before December 16, 2026.
